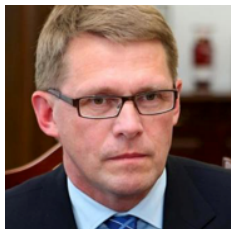
博古睿

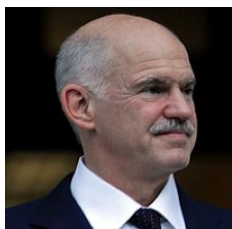
**戈登·布朗**

**赫勒·托宁·施密特**

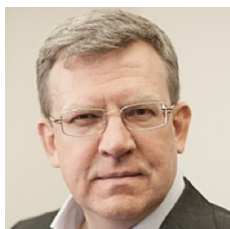

阿列克谢·库德林，1960年生，俄罗斯审计署署长、圣彼得堡大学人文科学系主任。2000至2011年担任俄罗斯政府财政部长，2000至2004年以及2007至2011年两次出任俄罗斯副总理。《银行家》杂志2014年“年度财长”、《欧元》杂志2010年“年度财长”。



**杨荣文**

杨荣文，1954年生，现任嘉里物流主席、嘉里集团控股董事。供职新加坡政府23年，先后担任新加坡新闻及艺术部部长、卫生部长、贸工部长及外交部长。



**文正仁**

文正仁，1951年生，韩国总统统一外交安保特别助理、韩国延世大学特聘教授、加州大学圣迭戈分校政策和全球战略学院特聘研究员、核不扩散与裁军亚太领袖网络召集人之一。



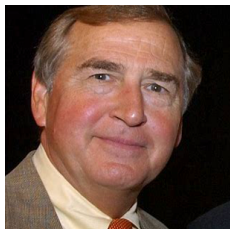
**戴维森勋爵**

帕斯卡尔·拉米，1947年生，世界贸易组织前总干事（2005至2013年）。曾先后担任法国财政部长和总理的顾问。1985至1994年，任欧盟委员会主席的办公厅主任。1999年至2004年，任欧盟委员会贸易专员。现任智库 Notre Europe 荣誉主席。



**格雷厄姆·艾利森**

格雷厄姆·艾利森，1940年生，哈佛大学肯尼迪政府学院首任院长、教授，哈佛大学贝尔弗科学与国际事务中心主任，上世纪七十年代以来美国最具影响力的国家安全和国防政策专家之一，曾先后担任里根政府的国防部长特别顾问以及克林顿政府的国防部长助理。著有畅销书《决策的本质：《还原古巴导弹危机的真相》（1971）、《注定一战：美国和中国能逃脱修昔底德陷阱吗？》（2017）等。



**戴敏**

戴敏，美中伙伴关系研究中心、美中合作基金会、美国中国投资集团和美国网络电视中心、巨灾重建金融控股有限公司总裁。她与丈夫怀特于2007年共同创建美中伙伴关系研究中心、美中合作基金会。



**内森·嘉德尔斯**

内森·嘉德尔斯，博古睿研究院联合创始人、高级顾问，《世界邮报》和《新观点季刊》主编，美国对外关系委员会和太平洋国际政策委员会成员。



**葛维宝**

葛维宝，1947年生，耶鲁大学法学院教授、中国中心主任，分别于1967年和1970年获得哥伦比亚大学文学学士学位与耶鲁大学法学博士学位。1997至1998年，担任克林顿政府国务院总统法治倡议特别代表。2015年，被评为《外交政策》“太平洋力量指数”（The Pacific Power Index）塑造未来中美国关系50人之一。



**洪锡炫**

洪锡炫，1949年生，韩国《中央日报》集团董事长，首尔大学电子工程学学士、斯坦福大学工业管理学硕士和经济学博士，世界报业联合会主席（2002至2005年），韩国报业联合会主席（2003至2005年），韩国前驻美大使（2005年）。



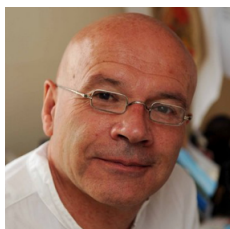
**胡祖六**

马丁·雅克，生于1945年，英国剑桥大学政治和国际研究系高级研究员，著有全球畅销著作《当中国统治世界：中国的崛起和西方世界的衰落》(2009)。



**刘遵义**

刘遵义，1944年生，香港中文大学前校长（2004-2010年）、斯坦福大学物理学与经济学学士、加州大学伯克利分校经济学硕士与博士。1976年，成为斯坦福大学经济系教授。1992年出任该系首任李国鼎经济发展讲座教授。1997至1999年，担任斯坦福经济政策研究所主任。刘遵义教授的研究领域包括经济发展、经济增长以及东亚经济体研究。



李世默

李世默，1968年生，加利福尼亚大学伯克利分校经济学学士、斯坦福大学商学院工商管理硕士、复旦大学政治学博士，担任成为资本的创始人兼董事总经理，上海中欧国际工商管理学院董事会成员，复旦大学中国研究院理事会成员。他经常为《纽约时报》、《外交事务》、《全球时报》、《南华早报》等报刊杂志撰写文章。

**约翰·米勒 - 怀特**

约翰·米勒 - 怀特，1952 年生，中美合作基金会执行主席，于 2007 年建立美中伙伴关系研究中心，曾任北京大学名誉研究员，北京对外经贸大学客座教授，中国人民大学风险投资中心高级顾问。2008 至 2010 年参与《中美商业新战略：开创中美商务双赢的未来》等多本中美伙伴关系系列著作的写作。



**中川黎明**

中川黎明，1971 年生，博古睿研究院执行副总裁。曾担任太平洋国际政策委员会执行副总裁，负责监管战略、组织发展和政策方面项目的执行情况。多恩拥有芝加哥大学 MBA 学位和麦吉尔大学学士学位。



**吉迪恩·拉赫曼**

吉迪恩·拉赫曼，1963 年生，自 2006 年起担任英国《金融时报》资深外交评论员，1997 至 2000 年间担任《经济学人》亚洲版主编。2016 年荣获奥威尔政治新闻奖，同年被欧洲新闻奖评为年度解说员。



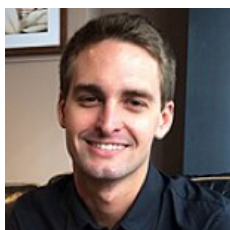
**史蒂芬·罗奇**

**古温·萨克**

**Ernesto Zedillo**

Ernesto Zedillo (born in 1951) is former President of Mexico (1994 - 2000). He is currently Director of the Center for the Study of Globalization, Professor of International Economics and Politics at Yale University and member of the Global Commission on Drug Policy. He was Chairman of the Global Development Network, the Oversight Board of the Natural Resource Charter, and the high-level Commission on Modernization of World Bank Group Governance.



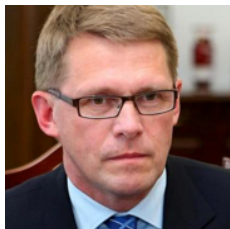
**Nicolas Berggruen**

Nicolas Berggruen (born in 1961), an American philanthropist and investor, is founder and Chairman of Berggruen Institute and Chairman of Berggruen Holdings. He is also the founder of the 21st Century Council, the Council for the Future of Europe and the Think Long Committee for California. He sits on the boards of the Museum Berggruen, Berlin, and the Los Angeles County Museum of Art. Berggruen is co-author with Nathan Gardels of *Intelligent Governance for the 21st Century: A Middle Way between West and East* (2012), a Financial Times Book of the Year.



**Punsalmaagiin Ochirbat**

Punsalmaagiin Ochirbat (born in 1942) is former President of Mongolia (1990 - 1997). He previously served as Minister for External Economic Relation and Cooperation (1987 - 1990) and member of the Constitutional Court of Mongolia (2005-2016). He is currently Chairman of the Board of Ochirbat Foundation.



**Matti Vanhanen**

Matti Vanhanen (born in 1955) was Prime Minister of Finland from 2003 to 2010. He was also Chairman of the Centre Party from 2003 to 2006. Currently, he is a member of the Finnish Parliament and Chairman of the Foreign Affairs Committee in the Parliament.



**Shaukat Aziz**

Shaukat Aziz (born in 1949) is former Prime Minister of Pakistan (2004-2007), and former Finance Minister of Pakistan (1999-2007). He currently serves on the Board of Directors of the Boao Forum for Asia, and The Blackstone Group, among others. He was named "Finance Minister of the year" in 2001 by Euromoney and The Banker magazine.



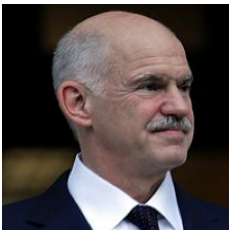
**Gordon Brown**

Gordon Brown (born in 1951) was Prime Minister of the United Kingdom and Leader of the Labour Party from 2007 to 2010. He previously served as Chancellor of the Exchequer from 1997 to 2007. He currently chairs World Economic Forum Global Strategic Infrastructure Initiative and serves as a member of the Global Agenda Council on Infrastructure.



**Bajnai Gordon**

Bajnai Gordon (born in 1968) is a Hungarian entrepreneur and economist, who was Prime Minister of Hungary from 2009 to 2010. He previously served as Minister of Local Government and Regional Development (2007-2008), and Minister of National Development and Economy (2008-2009). He is currently working as the Chairman of the Global Advisory Board of Campbell Lutyens and serving as a member of the Investment Committee of the European Fund for Strategic Investments.



**George Papandreou**

George Papandreou (born in 1952) is former Prime Minister of Greece (2009-2011), member of the Hellenic Parliament and former President of the Panhellenic Socialist Movement (PASOK). He is currently President of the Socialist International (since 2006). In 2010, Papandreou was named as one of Foreign Policy magazine's Top 100 Global Thinkers for "making the best of Greece's worst year".



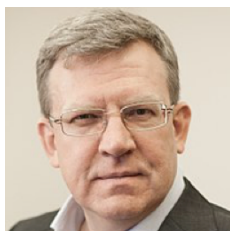
**Helle Thorning-Schmidt**

Helle Thorning-Schmidt (born in 1966) was Prime Minister of Denmark from 2011 to 2015, and Leader of the Social Democrats from 2005 to 2015, the first woman ever to hold either post. She is currently the Chief Executive Officer of Save the Children International.



**Yohei Kono**

Yohei Kono (born in 1937) was Speaker of the House of Representatives of Japan from and President of the Japan Liberal Democratic Party, Deputy Prime Minister and Minister of Foreign Affairs. He is one of the pro-Chinese members of the LDP, and is currently serving as President of the Japanese Association for the Promotion of International Trade.



**Alexei Kudrin**

Alexei Kudrin (born in 1960) is currently Chairman of the Accounts Chamber of Russia (since 2018), and Dean of the Department of Liberal Arts and Sciences of St. Petersburg State University. He previously served as Minister of Finance from 2000 to 2011 and twice as Deputy Prime Minister of Russia from 2000 to 2004 and from 2007 to 2011. The Banker magazine named Mr. Kudrin "Finance Minister of the Year 2004" and the Euromoney magazine named him "Finance Minister of the Year 2010".



**George Yeo**

George Yeo (born in 1954) is Chairman of Kerry Logistics Network and a Director of Kerry Holdings. From 1988 to 2011, he served 23 years in Government, as Minister for Information and the Arts, Health, Trade & Industry, and Foreign Affairs.



**Moon Chung-in**

Moon Chung-in (born in 1951) is Special Advisor to the South Korean President Moon Jae-in for Unification, Foreign Affairs and National Security. He is also a Distinguished University Professor at Yonsei University, Kraus Distinguished Fellow, School of Policy and Global Strategy at the University of California, San Diego, and a co-Convener of the Asia-Pacific Leadership Network for Nuclear Non-Proliferation and Disarmament.



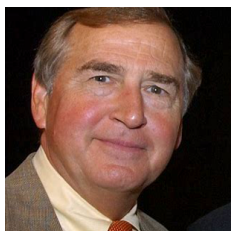
**Lord Neil Davidson**

Lord Neil Davidson is shadow Treasury minister and shadow Advocate General for the Labour Party in the UK and is a parliamentarian in the UK House of Lords. He was a minister law officer (Advocate General) in the UK governments of Prime Ministers Blair and Brown from 2006 to 2010. He was minister law officer (Solicitor General) in the Scottish Government for 2 years to 2002.



**Pascal Lamy**

Pascal Lamy (born in 1947) is former Director-General of the World Trade Organization (WTO) (2005-2013). He became an advisor to the Finance Minister and Prime Minister. From 1985 to 1994, he was Chief of staff for the President of the European Commission. Between 1999 and 2004, Pascal Lamy was Commissioner for Trade at the European Commission. Pascal Lamy is currently the Honorary President of the Paris-based think-tank Notre Europe.



**Graham Allison**

Graham Allison (born in 1940) is Founding Dean and Douglas Dillon professor at the John F. Kennedy School of Government at Harvard, and Director of the Belfer Center for Science and International Affairs. Since the 1970s, Allison has been a leading analyst of U.S. national security and defense policy. He served as Assistant Secretary of Defense under President Clinton and Special Advisor to the Secretary of Defense under President Reagan. He is author of several bestsellers, such as, *Essence of Decision: Explaining the Cuban Missile Crisis* (1971), and *Destined for War: Can America and China Escape Thucydides' s Trap ?* (2017).



**Dai Min**

Dai Min is President of Center for America China Partnership, America-China Partnership Foundation, Whyte-DaiMin Investments Limited, the Global Internet Television Network and Catastrophe Recovery Finance Holdings Ltd. In 2007 she co-founded with her husband Miller Whyte the Center for America China Partnership and America-China Partnership Foundation.



**Nathan Gardels**

Nathan is Co-founder of and Senior Advisor to the Berggruen Institute. He serves as Editor-in-Chief of *The WorldPost* and *New Perspectives Quarterly*. He is also a member of the Council of Foreign Relations, and the Pacific Council on International Policy.



**Paul Gewirtz**

Paul Gewirtz (born in 1947) is the Potter Stewart professor of constitutional law at Yale Law School and director of the China Center at Yale. Gewirtz received his A.B. degree from Columbia University in 1967 and his J.D. degree from Yale Law School in 1970. From 1997 to 1998, Gewirtz was part of President Bill Clinton's administration, where he served as Special Representative for the Presidential Rule of Law Initiative at the U.S. Department of State. In 2015, Gewirtz was named to Foreign Policy magazine's Pacific Power Index, a list of "50 people shaping the future of the U.S.-China relationship".



**Hong Seok-hyun**

Seok-Hyun Hong (born in 1949) is Chairman of the JoongAng Holdings. Hong received his bachelor's degree in electronics engineering from Seoul National University, and earned both a master's in industrial engineering and a Ph.D. in economics from Stanford University. He served as President of the World Association of Newspapers from 2002 to 2005, and President of the ROK's Korea Association of Newspapers from 2003 to 2005. He was appointed ROK Ambassador to the U.S. in 2005.



**Fred Zuli Hu**

Fred Zuli Hu (born in 1963) is Chairman and President of Primavera Capital Group, and professor at School of Economics and Management and Director at the National Center for Economic Research (NCER) at Tsinghua University. Fred served as an economist at the International Monetary Fund in Washington D.C., from 1991 to 1996. He was Greater China Chairman and partner for Goldman Sachs from 2008 to 2010. Fred holds a PhD in economics from Harvard University.





**Arianna Huffington**

Arianna Huffington (born in 1950) is a Greek-American author, syndicated columnist, and co-founder of The Huffington Post. In 2016, she launched Thrive Global, and has since served as its CEO. Huffington was named to Time Magazine's list of the world's 100 most influential people (2006) and the Forbes Most Powerful Women list (2009). She graduated from Cambridge University with an M.A. in economics.



**Martin Jacques**

Martin Jacques, born in 1945, is Senior Fellow at the Department of Politics and International Studies at the University of Cambridge. He is the author of the global bestseller *When China Rules the World: the End of the Western World and the Birth of a New Global Order* (2009).



**Lawrence Lau**

Lawrence Lau (born in 1944), is former Vice President of the Chinese University of Hong Kong (2004-2010). He received his B.S. degree in physics and economics from Stanford University, and his M.A. and Ph.D. degrees in economics from the University of California, Berkeley. He was promoted to Professor of Economics at Stanford in 1976, and was named the first Kwoh-Ting Li Professor of Economic Development at Stanford University in 1992.
